



| 4.4 | The employees retired under Safety Related Retirement Scheme(SRRS)/Liberalized Active Retirement Scheme for Guaranteed Employment for Safety Staff (LARSGESS) are also not eligible for re-engagement. | | | | | | | | | | | | | | | | |
| 4.5 | Monthly remuneration of a retired employee being re-engaged will be determined by reducing pension from his/her last pay drawn. (i.e., Basic Pay + D.A) | | | | | | | | | | | | | | | | |
| 4.6 | The re-engaged employees are not entitled for any other benefit or any other facilities except monthly fixed remuneration. | | | | | | | | | | | | | | | | |
| 4.7 | The re-engaged retired Railway employee, will not be eligible for any kind of leave like (CL, LAP, LHAP etc.). Absence, if any, appropriate deduction will be made from the monthly remuneration. | | | | | | | | | | | | | | | | |
| 4.8 | Re-engagement of retired employees shall be subject to prescribed medical fitness for the posts in para Medical category in which they are re-engaged. | | | | | | | | | | | | | | | | |

| 4.11 | The Re-engaged Staff shall be discharged immediately on joining of selected candidate from RRBs. |
| 5.0 | How to apply |
| 5.1 | Applications should be submitted strictly in the prescribed format as per Annexure. It shall be filled in A-4 size paper. |

| 5.3 | One passport size photograph should be pasted on the application form at the space specified. |
